

REGULAR MEETING

The Regular Meeting of the Hempfield Township Board of Supervisors was held on Tuesday evening, June 3, 2020, at 7:00 P.M. in the Township Municipal Building.

Supervisors Gary E. Hittle, David A Geisel and Todd P. Hittle were present. Dick Stanley of 8 Fox Creek Drive was present as well.

Chairman Gary Hittle called the Regular Meeting to order.

Chairman Hittle opened the meeting for Public Comment. There was none.

Chairman Hittle said he would entertain a motion to dispense with the reading and approve of the Minutes of the Regular Meeting of May 5, 2020. Supervisor Geisel made a motion to approve the minutes from the May, 2020 meeting and it was duly seconded Supervisor Hittle and unanimously approved by Chairman Hittle. Motion carried. Chairman Hittle said the minutes are a public document and may be viewed at any time during regular business hours.

Chairman Hittle noted the resignation of Zoning/Property Maintenance Officer John G. Bost has been submitted and the Board will appoint Mr. Richard G. Stanley of 8 Fox Creek Drive to fill the vacancy. A motion by Supervisor Geisel to accept the resignation and appointment was made and duly seconded by Supervisor Hittle. It was unanimously approved by Chairman Hittle. Motion carried.

Chairman Hittle noted that the Hempfield Township Building and offices will be closed Friday, July 3rd for the Independence Day holiday.

Chairman Hittle said that there are activities for the Hempfield Township Volunteer Fire Department which must be approved by the Supervisors at this time. They are: June 4- Training; June 5,6,7- Station Clean Up; June 8- Directors/Membership Meeting; June 11- Line Officers meeting; June 18- Training. Motion by Supervisor Geisel to approve the activities for June and it was duly seconded by Supervisor Hittle and unanimously approved by Chairman Hittle. Motion Carried.

Next on the Agenda is the viewing of reports of the various Township departments. The police report for the month of May was first presented. The Men worked 785 man hours and traveled 5,360 miles. They issued 10 traffic citations, and 9 non-traffic citations. There were 5 accidents with 3 injuries. There were 508 criminal-related incidents, 68 service incidents, 19 police information, and 75 additional traffic related incidents. Property stolen was in the amount of \$874.00 with \$874.00 recovered and no property was damaged.

The fire report was then reviewed. There were 14 incidents, 2 fires, 2 Explosions, 3 EMS, 6 Good Intent Calls and 1 False Alarm.

There were 3 zoning permits issued by the Zoning Administrator for the month of May. They were issued as follows: TNT Fireworks for a temporary fireworks tent located at 45 Williamson Road for an estimated market value of \$500.00; Todd Stake of 275 Hamburg Road for a Barn/Garage at an estimated market value of \$33,000.00 and 359 Associates LLC of 359 Mercer Road for a Tractor Shed at an estimated market value of \$4,500.00.

The Maintenance Report for May was reviewed next. Ditching along Township roads; Sweeping with back broom along rural Township roads; Cut driveway for culvert pipe replacements on Redwood and Hemlock Drives; Cleaned ditches along Redwood and Hemlock Drives; Serviced/oiled salt spreaders for summer storage; Serviced John Deere Backhoe; Power washed ditcher/Massey Ferguson Tractor; Power washed back broom; Power washed pavilions at Park; Turned water on at Park; Sweeping Township Roads; Back filling along guide rails along Hamburg Road; Fixed/repaired traffic signal at Hadley/Williamson Roads; Scrapped old Gravely Mower; Worked on HTPD Unit#2; Working with Standard Pipe on sewer maintenance project; Reviewed sewer project with contractor in field; Cleaned parking lot at Township Building; Washed HTPD vehicles numerous times; Cleaning intersection of winter maintenance materials; Cleaning/Power washing outhouses at Park; Cut grass at locals around Township; Set up Park for pavilion rentals; Painting new trash cans at park; Provide escort for ditcher/mower along Hamburg Road; Cut grass and weed eat at park; Replaced culvert pipes along St.Glory, Quarry Hill and Sherrard Ave; PA One Calls located in field; Repaired ditch along Hamburg Road; Patched potholes along Frye Road and Gruber Road; Worked on Ford Pickup; Worked on GMC Dump Truck; Fixed AC in HTPD Unit#2; Worked in replacement of Park Playground Equipment; Put up flags at park for Memorial Day; Mowed at Park; Mulched Playground at Park; Cutting/weed eating corners at Township/State Road intersections.

Chairman Hittle opened the miscellaneous portion of the meeting. There were no comments.

Chairman Hittle said he would entertain a motion that checks be issued in payment of all utility bills, and that all other bills be checked and upon approval, be paid. Supervisor Geisel made that motion and it was duly seconded by Supervisor Hittle and unanimously approved by Chairman Hittle. Motion carried.

There being no further business, Supervisor Hittle made a motion to adjourn. The motion to adjourn was duly seconded by Supervisor Geisel and unanimously approved by Chairman Hittle. Motion carried.

Chairman Hittle declared the Meeting adjourned.
